

CHECKLIST CUM ACTION PLAN FOR REGISTRATION OF AIRCRAFT AND / OR CERTIFICATE OF AIRWORTHINESS

The following checklist is applicable for registration of an aircraft only and is additional to the requirements for an applicant for AOC/Authorisation or the addition of an aircraft to an existing AOC/Authorisation holder. This checklist is not exhaustive and is for guidance only.

NOTE: 1. IN ADDITION TO ITEMS IN THIS CHECKLIST; THE OWNER/OPERATOR MUST ENSURE ADHERANCE TO BAHRAIN AIR NAVIGATION TECHNICAL REGULATIONS (ANTR) AND PROCEDURES.

- **2**. The **PART-I** of the Checklist cum action pan shall be submitted by the Owner / Operator who intends to apply only for the Certificate of Registration. The Part II and the associated applications & checklists for the Certificate of Airworthiness shall be submitted when they are ready for Certificate of Airworthiness.
- **3**. The **PART- I & II** and associated applications & checklists shall be submitted together by the Owner / Operator if they intend to apply and obtain both Certificate of Registration and Certificate of Airworthiness together under one process.
